

2016 JAGUARS GET MORE GIVEAWAY
OFFICIAL TERMS & CONDITIONS

By participating in the 2016 Jaguars Get More Giveaway (the “Giveaway”), you agree to be bound by these terms and conditions. Failure to comply with these terms and conditions may (in the sole discretion of the Jaguars) result in disqualification from your ability to redeem your gift.

The Giveaway is void where prohibited or restricted by applicable laws, rules and legal requirements, and all applicable federal, state and local laws, rules and legal requirements apply. By scratching off an official Get More Giveaway voucher containing a valid serial number (the “Voucher”), Recipients are eligible to redeem a gift designated by the Jaguars. “Recipients” means individuals in receipt of a Voucher who are eligible to redeem a gift in the Giveaway.
